# Minutes of Meeting of Gunlake Quarries Community Consultative Committee held at Marulan at 10.00am on 19 October 2018

#### 1) Attendance:

- 3) Declaration of pecuniary or other interests:

- 4) Minutes of meeting held on 27 July 2018 were confirmed.
- 5) Business arising from the Minutes:
  - a) Noise Monitoring Report from EPA of 3 August 2018 Dennis Isbister maintained his concern with winter time noise levels.
  - b) Section 94 Contributions. Members were directed to GMC Business Paper of 2 October 2018, Item 12(b). Scott Martin confirmed that all Gunlake S94 contributions are used for the Gunlake Haul Route and explained GMC intention to re-sheet the road. Discussion ensued on future road maintenance and expenditure, including the secondary haul route. Ken Wray asked whether S94 contributions can be used for litter control. Scott did not believe it could be but suggested that such issues should be reported to GMC. Council will inspect the haul routes about each week and on demand. Re-sheeting will occur approximately every 7 to 10 years. It may undertake some work near the junction with the Hume Highway.
  - c) Road Upgrades and signage Ron Switzer has asked GMC for two signs on Red Hills Road at the Hume Hwy end, one speed advisory 40 km/h and one for hidden driveway. Scott Martin to take back to GMC.
